In accordance with 840 CMR 16.07, the Board met with Mr. Kevin Condy, Director of Research and Mr. Gregory McNeille, Vice Chairman and Principal of Dahab Associates, Inc. for the 3rd Quarter 2023 Investment Performance Analysis. Presentation material was distributed.

- In accordance with 840 CMR 16.07, the Board met with Ms. Christina Emery, Managing Director and Mr. Stephen Jarvis, Managing Director of Barings via conference call for the Annual Performance Review of the **Tower Square Capital Partners IV**, **L.P. Fund**. Presentation materials were distributed and fund performances were discussed.
- In accordance with 840 CMR 16.07, the Board met with Mr. Patrick Brown, Vice President of Portfolio Advisors via conference call for the Annual Performance Review of the **PAPEF III Secondaries Fund**. Presentation materials were distributed and fund performances were discussed.

The following **ADMINSTRATIVE ISSUES** were discussed and action taken as individually noted:

- Mr. Brock reported on his transition plan for a new Chairman of the Hampshire County Retirement Board. A review of the job description will be done to determine which duties can be delegated to the staff members.
- Upon Mr. Chadwick's motion and Ms. Wolfe's second, the Board voted unanimously to reduce the Chairman's monthly stipend from \$4,000.00 a month to \$2,000.00 a month effective January 1, 2024.
- Upon Mr. Mangano's motion and Mr. Chadwick's second, the Board voted unanimously to retain the service of Mary Flanders Aicardi of the Collins Center to assist in recruiting a new Chairman of the Hampshire County Retirement Board.
- Ms. Baronas reported that 1) the Jane Wolfe has been re-elected by the Hampshire Count Advisory for another 3-year term as the appointed member of the Hampshire County Retirement Board, term dates are January 1, 2024 December 31, 2026; 2) presented the Administrative Budget for 2024; and 3) reported that fraudulent checks were drawn on the Money Market account. Due to the policies that were in place, the fraud was caught, stopped and no funds were lost. As a precautionary measure, a new account has been established.
- Upon Mr. Chadwick's motion and Mr. Mangano's second, the Board voted to approve the 2024 Administrative Budget in the amount of \$963,751.00.
- Ms. Baronas presented to the Board her Self-Performance Evaluation. Ms. Baronas reported that she has not received the salary increase that was granted to the staff of the Hampshire County Retirement System in 2022 or 2023. Ms. Baronas requested that she be awarded the 4% increase for 2022 retroactive to her anniversary date of June 10, 2022 and the 3% increase for 2023 retroactive to her anniversary date of June 10, 2023. Upon Mr. Mangano's motion and Mr. Cook' second, the Board voted unanimously to grant the 4% salary increase for 2022 retroactive to June 10, 2022 and a 3% salary increase retroactive to June 10, 2023 for Mary Baronas.
